• **Action Plan-Vision Zero**

 - The Sheriff’s staff produced an accident and crash report for 2017-2021 for all County roads. This data is being combined with State/Fed for true countywide view of accidents.

- Recommend approving overall Action Plan/Edition 1 with Supervisor amendments and changes
